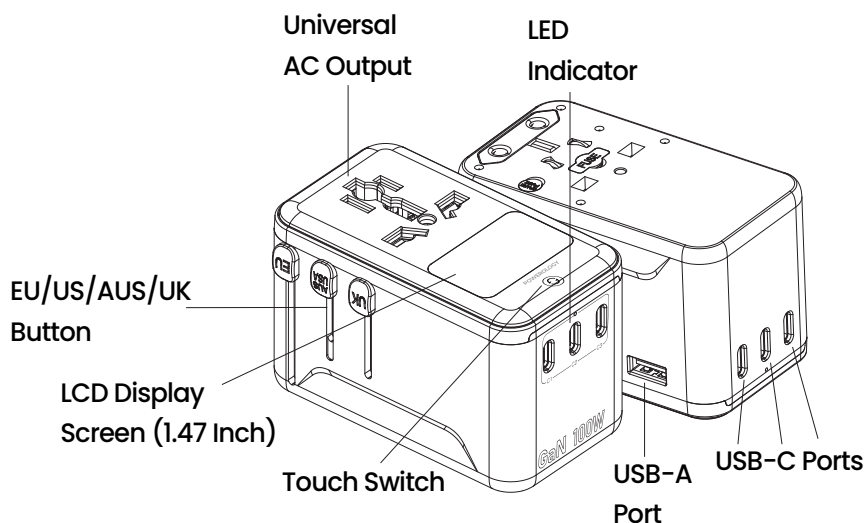
Product Overview

The adapter is made from fireproof materials and includes a travel lock and dual fuses for added safety.

Fuse Replacement Guide



1. When the travel adapter is used with high-power devices that exceed the standard, the fuse may blow. In this case, a new main fuse needs to be replaced. All pins should be reversed, and a screwdriver or similar tool should be used to pry open the main fuse cover.

2. The main fuse can be removed along with the fuse cover. At the same time, pry open the spare fuse cover, install the spare fuse into the main fuse cover, and reinstall it in its original position.

Note: This adapter does NOT convert voltage. To use an AC-powered electric device abroad, please ensure it supports dual voltage (with "100-250V, 50/60Hz" printed on it).

Safety Precautions

1. Before use, please carefully read these instructions. This product does not convert voltage (AC to AC). To avoid potential damage to your device or other safety hazards, ensure that the power outlet you intend to use has the correct voltage to operate your device before using this adapter.

2. Each country has its own regulations regarding the use of travel adapters. Please verify the regulations in each country before use.
3. This product is for use with unearthed or double-insulated appliances only and does not provide grounding.
4. The adapter is compatible with over 180 countries, covering regions with US, AUS, EU, and UK plugs.
5. Built-in safety shutters protect users from direct contact with the live parts of the socket outlet.
6. Only one plug type can be used at a time. Other plug pins will be automatically locked.

FCC Statement
